However as per section 3 of the same addendum 4, bidders are required to also use specification document number KP1-6C 1-13-TSP-11-46 which is for indoor panels to design Outdoor marshalling kiosks among other panels. a. Are we supposed to use that specification document number KP1-6C 1-13-TSP-11-46 and fill its gtp for the | The requirement for Outdoor Marshalling Kiosks is for Lessos substation. Generally most of the aspects for this MBs is covered under KPLC document number KP1-6C-4-1-TSP-11-046-2 (for Outdoor MBs), which is what is attached. The other unique requirements for use at Lessos substation, are contained in the main Tender document KP1/9A.3/OT/35/23-24. In case of any conflict in the two documents, the requirements on the main tender document, takes precedence as the MBs will be used specifically at Lessos. |
