ADDENDUM 1 TO TENDER NO. KPI/1/3A/4/1/EOI/001/20-21 ON LISTING OF FIRMS FOR THE DEVELOPMENT OF CAPTIVE SOLAR GENERATION FOR KPLC'S COMMERCIAL & INDUSTRIAL CONSUMERS

The following amendment has been made to the specified provisions of the Tender document on EOI for LISTING OF FIRMS FOR THE DEVELOPMENT OF CAPTIVE SOLAR GENERATION FOR KPLC'S COMMERCIAL & INDUSTRIAL CONSUMERS dated JANUARY 2021.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect.

The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

2. JOINT VENTURE

Tenders submitted by a joint venture of two or more firms, as partners shall comply with the following requirements: -

- a) In case of a successful tender, the Contract Agreement Form, shall be signed so as to be legally binding on all partners of the joint venture.
- b) One of the partners shall be nominated as being lead partner, and this authorization shall be evidenced by submitting a Power of Attorney signed by legally authorized signatories of all the partners.
- c) The Power of Attorney which shall accompany the tender, shall be granted by the authorized signatories of all the partners as follows:-
 - (i.) For local bidders, before a Commissioner of Oaths or a Notary Public or Magistrate of the Kenyan Judiciary.
 - (ii.) For a foreign bidder, before a Notary Public, or the equivalent of a Notary Public, and in this regard the bidder shall provide satisfactory proof of such equivalence

- d) The lead contractor shall be authorized to incur liability and receive instructions for and on behalf of any and all the partners of the joint venture and the entire execution of the contract including payment shall be done exclusively with the lead contractor.
- e) All partners of the joint venture shall be liable jointly and severally for the execution of the contract in accordance with the contract terms, and a relevant statement to this effect shall be included in the authorization mentioned in (b) above as well as in the Contract Agreement Form (in case of the accepted tender).
- f) A copy of the agreement entered into by the joint venture partners shall be submitted with the tender.

*** NOTE:**

If a firm considers that it does not have all the expertise for the assignment, it may obtain a full range of expertise by associating with individual consultant(s) and/or other firms or entities in a joint venture or sub-consultancy as appropriate. Firms/Consultants shall not associate with the other firms/consultants invited for this assignment. Any firms associating in contravention of this requirement shall automatically be disqualified.

3. PRE-QUALIFICATION CRITERIA

Bidders are requested to kindly adhere to the requirements of the EOI Tender Document

4. OBTAINING TENDER (EOI) DOCUMENT.

The Tender document detailing the requirements may be obtained from the KPLC E- Procurement Portal under 'Training School'

On registration to our portal, kindly visit our website www.kplc.co.ke. Next to the word SAP, click on manual, once the window opens, scroll down and click on number 5. Supplier Relationship Management. That is a user guide on how to register as a vendor with KPLC.

Prospective bidders may also download the tender document from KPLC's website (www.kplc.co.ke) free of charge.

*** NOTE:**

KPLC is on E-procurement, and one can only participate in our tendering process, via the portal. Bidders need to be registered on our KPLC's IESR (Training school) portal to access the EOI tender document, as well as participate in the tendering process.

5 SUBMISSION OF TENDER DOCUMENTS

Completed Tenders are to be submitted in electronic format on the KPLC's E-procurement portal under IESR (Training School) on the due date and time published on the portal. Tenderers are required to visit the portal from time to time for revised closing dates and addendums. The Tender is to be submitted **ONLINE** on or before the submission date and time indicated on the **KPLC tendering portal**.


4. TENDER CLOSING DATE

The Tender closing date has been extended from **Wednesday 10th February, 2021** to **Wednesday 24th February, 2021** at 10.00 am and shall be opened promptly at 10.30am.
