RE: ADDENDUM NO. 1 TO THE TENDER NO. KP1/9A.3/OT/12/21-22 FOR SUPPLY OF LOW VOLTAGE (LV), MEDIUM VOLTAGE (MV) AND HIGH VOLTAGE (HV) FITTINGS

The following amendment has been made to the specified provisions of the Tender document for Supply of Low Voltage (Lv), Medium Voltage (Mv) and High Voltage (Hv) Fittings dated March 2022.

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT

Save where expressly amended by the terms of this Addendum, the Principal Tender Document shall continue to be in full force and effect.

The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal Tender Document.

2. AMENDMENT OF SECTION II - TENDER DATA SHEET (TDS) - ITT 40

All prospective bidders are informed that Clause 1 on the award criteria initially indicated as; "Award shall be on item-to-item basis to the bidder with the lowest evaluated price per item as per their eligibility as stated above in TDS ITT 2.3" is hereby amended to read "Award shall be on item-to-item basis to the bidder with the lowest evaluated price per item as per their eligibility as stated above in TDS ITT 3.1"

3. AMENDMENT OF SECTION III - PART I ON PRELIMINARY EVALUATION CRITERIA.

The evaluation criteria has been amended as below;

(For companies or firms that are registered or incorporated within the last one calendar year of the Date of the Tender Document, they should submit certified copies of bank statements covering a period of at least six months prior to the date of the tender document. The copies should be certified by the Bank issuing the statements. The certification should be original).		
12	Submission of duly filled Historical Contract Default in performance and/or unresolved cases form (Form 3.2). Record of unethical practices or unsatisfactory or default in performance obligations in any contract shall be considered. This shall include any tenderer with unresolved case(s) in its conduct or performance obligations for more than two (2) months in any contract where the failure to resolve is not attributable to KPLC. 2	Bidders Eligible for Lot 1 are Local Manufacturers and for Lot 2 are Local Bidders. Can a "Local Manufacturer" Quote for both Lots 1 & 2?	Yes. However, Lot 1 is reserved exclusively for Local manufacturers only.
3	Page 8: No: 12- are we required to provide Catalogues and or Brochures?	Yes, bidders should provide Catalogues and/or Brochures? Drawings and GTPS are however mandatory.
4	Page 42-43: Are we required to fill in the blank spaces?	No- These will be filled during the due diligence visit.

5. AMENDMENT OF SECTION IV AND V ON THE PRICE SCHEDULE, SCHEDULE OF REQUIREMENT AND GUARANTEED LEAD TIME FORM.

All prospective Bidders are informed that the **item Code 184821- Insulator Pin 11kv Porc. C/W Spindle** has been removed from the schedule of requirements.

The delivery schedule for universal clamps have also been adjusted from two (2) weeks to one (1) month.

The above changes will affect Section IV- Price Schedule, Section V – Schedule Of Requirements and the Guaranteed Lead Time Form. Bidders are therefore advised to take note and adjust accordingly.
