3. AMMENDMENT

a) Amendment to **SECTION VII 6.1.4** include(f)-Names with full contact as well as physical addresses of previous customers of similar goods and reference letters from at least four (4) previous customers confirming successful completion of purchase orders on schedule. **Reference Letters are from the manufacturer.**

b) **SECTION VII 6.1.10** has been amended to read as follows:

For Limited companies submission of audited financial statements required must be those that are reported within eighteen (18) calendar months of the date of the

tender document accompanied by a **valid auditor/audit firm ICPAK license**. For companies or firms that are registered or incorporated within the last one calendar year of the Date of the Tender Document, they should submit certified copies of bank statements covering a period of at least six months prior to the date of the tender document. The copies should be certified by the Bank issuing the statements. The certification should be original.

For Sole Proprietorships, Partnerships and firms owned by PWD's submit bank statements certified by the Bank issuing the statements. The certification should be original.

The bidders are required to take note that the tender closing date has been extended to **23rd March, 2021 at 10:00 am**.
