Please refer to the above Tender. We make the following amendments to the Principal Tender Document (*hereinafter abbreviated as the PTD*) for Supply of Smart Large Power Metering units

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT (PTD)

Save where expressly amended by the terms of this Addendum, the PTD shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read and construed as part of the PTD.

2. SECTION III -INSTRUCTIONS TO TENDERERS

Appendix to instructions to tenderers

Clause 3.2.1 Eligible Tenderers- This is an International tender.

The clause is amended to read -This tender is for **Manufacturers only**.

Clause 3.16.1 Samples-The successful bidder(s) shall be required to submit 3 pcs of sample for Single phase & 3phase for approval after award.

The clause is amended to read-3pcs of Single phase and 3 pcs of Three Phase samples shall be submitted before the closing date at Stima Plaza, 3rd Floor, Supply Chain office.

3. SECTION VI EVALUATION CRITERIA

Clause 6.2.3 *Table 1- Manufacturer's Capacity Declaration Form*

No. 6 has been amended to read KPLC requirement is **5 Months**.

4. SPECIFICATIONS-KP1/13D/4/1/TSP/14/11-04 & KP1/13D/4/1/TSP/14/11-05

The below clauses of the Single Phase and 3 phase of the specifications are amended to read as follows;

(a) Single Phase Specification**4.1.1 Functionality Requirements -4.1.1.1 Measurement and Control Unit (MCU)**

Clause 4.2.3.1.17 of KP1/13D/4/1/TSP/14/11-05- The MCU shall be supplied together with a plastic card of dimension 85 mm x 54 mm (length x height) indicating the meter number. A tolerance of ± 1 mm will be acceptable. The meter serial number shall be engraved on the card together with its bar code version. No random redundant digits shall be added to the meter number.

(b) 3 Phase Specification**4.2.2 Functionality Requirements -4.2.4.1 Measurement and Control Unit (MCU)**

Clause 4.2.4.1.24 of KP1/13D/4/1/TSP/14/11-04-The MCU shall be supplied together with a plastic card of dimension 85 mm x 54 mm (length x height) indicating the meter number. A tolerance of ± 1 mm will be acceptable. The meter serial number shall be engraved on the card together with its bar code version. No random redundant digits shall be added to the meter number.

5. DEADLINE FOR SUBMISSION OF TENDER - Section III – Clause 3.21

The bidders are required to take note that the tender closing date has been extended to **29th June 2021 at 10:00am**.

All other terms and conditions remain as per the Principal Tender Document (PTD).
