**Clause 3.17.1** Period of Warranty- The Warranty will remain valid for sixty (60) months from the date of delivery to KPLC stores.

**4. TENDER SPECIFICATIONS**

Clause 4.2.2.13 Page 15 SPECIFICATION KP1/13D/4/1/TSP/14/11-05

The communication module shall support USSD, CSD Communication-This is not a mandatory requirement.

**Clause 7.1 (K)** Evidence of the manufacturer having supplied a minimum of 200,000 pieces of the meter type offered to similar utilities in the past two years.

The clause is amended to read -Evidence of the manufacturer having supplied a minimum of **15,000 pieces** of the meter type offered to similar utilities in the past two years.
