a) Bidders are not required to provide "proof on how they shall meet the requirements" in their submission.	i)The requirements on the Specific Details of Service (Bidders required to tick YES to each detail of service) serves as a commitment on the part of the agency that wins the bid that they will be able to undertake the requirements as specified during the contract period.
b.) In reviewing the pitch extract from page 25 to 27. This requirement involving the use of agencies, intellectual property, constitutes a core billable service for professional consultants according to global best practices. Participating agencies	ii)The Pitch is a critical requirement in gauging the technical capability of the bidders and for the evaluation team to make a fair assessment of the bids. All the requirements of the Pitch as per the tender document are therefore key in bidder submissions, as has been in the case for all previous tenders. Kenya Power assures all
