ADDENDUM NO.1 FOR TENDER NO. KP1/9A.4/OT/TPT/14/23-24 FOR SUPPLY OF AUTOMOTIVE FUEL & LUBRICANTS & RELATED PRODUCTS THROUGH THE BIDDERS RETAIL DISTRIBUTION NETWORK

1. RELATIONSHIP WITH THE PRINCIPAL TENDER DOCUMENT.

Save where expressly amended by the terms of this Addendum, the Principal tender document shall continue to be in full force and effect.

The provisions of this Addendum shall be deemed to have been incorporated in and shall be read as part of the Principal tender document

2. SECTION IV- PRICE SCHEDULE -CREDIT PERIOD

Bidders attention is brought to requirements of line item no. 3 on the price schedule which states as follows;

"The minimum credit period extended to KPLC shall be forty (40) days after issuance of invoice and the requisite documentation".

Bidders are required to note that the requirement has been changed to read as follows;

"The minimum credit period extended to KPLC shall be Thirty (30) days after issuance of invoice and the requisite documentation"

3. SECTION V- GUARANTEED TECHNICAL SPECIFICATIONS – (4) PAYMENT TERMS

Bidders attention is brought to requirement of the guaranteed technical specifications – (4) Payment Terms (i) which states as follows;

"The minimum credit period extended to KPLC shall be forty (40) days after issuance of invoice and the requisite documentation".

Bidders are required to note that the requirement has been changed to read as follows;

"The minimum credit period extended to KPLC shall be Thirty (30) days after issuance of invoice and the requisite documentation"

4. SECTION IV- FORM 3.2 - HISTORICAL CONTRACT DEFAULT IN PERFORMANCE AND/OR UNRESOLVED CASES

Bidders are required to note amendments on Form 3.2 Historical Contract default in performance and/or unresolved cases. The amended Form 3.2 is now attached as **Appendix 1**.

5. DEADLINE FOR SUBMISSION OF TENDER

The closing date for the tender has changed from 08th April 2024 to **12th April 2024** at the time specified in the KPLC's tendering portal.

All the other terms and conditions remain as per the tender document.
