REF: ADDENDUM 1-TENDER NO.KP9/9A/OT/HRA/03 /23-24 FOR PROPOSED CONSTRUCTION OF A BOUNDARY WALL AT MAMBOLEO STOCK YARD.

Please refer to the above Tender. We make the following amendments to the principal Tender Document (hereinafter abbreviated as the PTD) for of proposed Construction of a boundary wall at Mamboleo Stock Yard.

1. Relationship with the Principal Tender Document (PTD)

Save where expressly amended by the terms of this Addendum, the PTD shall continue to be in full force and effect. The provisions of this Addendum shall be deemed to have been incorporated in and shall be read and construed as part of the PTD.

2. Change in the Principal Tender Title

Due to budget constraints, cable works were dropped and prioritized walling, hence the construction of the boundary wall alone as per PTD.

3. Project Duration

The project's duration is 28 weeks

4. Preliminaries

Preliminaries to be applauded with the addendum

5. Guard House

The proposed works does not include construction of a guardhouse

6. Site Location

The site covers the entire area including the substation

7. Submission of the completed Document

Submission is strictly online

8. Submission of Bid Bond

The original bid bond to be manually submitted and dropped in the tender box located at the main entrance next to security desk and a copy of the same attached to the principal tender document be submitted online.

9. Works Personnel

The foreman/works supervisor should be a holder of a minimum of a diploma /civil engineering from a recognized institution.

10. Machinery and Equipment

Necessary machinery and equipment of the works shall include concrete mixer, patching machine, poke vibrators, compressor, excavator, Lorries among others.

You may either show ownership or lease agreement.

11. Tender Document

The document should be downloaded, handwritten and then applauded.

12. CLARIFICATION ON THE DRAWING

- (i) Spacing of the columns is 3m Centre to Centre
- (ii) Lazor wire is fixed in two layers as described in the BQ
- (iii) The size of the intermediate column bases is 1200 x 1200mm
- (iv) The size of the intermediate columns is 300 x 300mm
- (v) The height of the wall from the ground beam is 2400mm
- (vi) The columns project 300mm above the super structure wall level

The tender submission date remains 17th January, 2024 at 10.00am.

Tenders shall be opened thereafter.

All other terms and conditions remain as per the Principal Tender Document.
