The following clarifications have been made with respect to item as specified below:


Query No.	Clarification Sought by Bidder	KPLC Response

Where the presentation is large, a flash disk and or CD should be prepared with the presentation and delivered before the opening of the tender in the Tender Box on 3 <sup>rd</sup> floor clearly labelled.
2.	What format of the presentation acceptable is	General, except Apple

3.	Who should certify (CV) & Academic certificates	Academic certificates must be certified by an Advocate or commissioner for oaths. All copies of certificates must be accompanied by copies of IDs, Signature and Tel. numbers of the owners.
4.	On price schedule the cost of jingle must be separate	Yes, as indicated in the price sachedule of tender document
