- b. Manufacturers Authorization duly filled and signed (where applicable)
- c. A copy of the Manufacturer's valid quality management system certification i.e. ISO 9001:2015 for goods and/or valid KEBS Diamond Mark of Quality and/or Standardization Mark Certificate for goods manufactured in Kenya.
- d. Technical Drawings and Catalogues and/or Brochures
- e. Schedule of Guaranteed Technical Particulars (GTPs) as per tender specifications.
- f. KPLC vendor approval letter


3. CHANGE OF TENDER CLOSING DATE (TENDER DATA SHEET – ITT 21.1)
