RE: ADDENDUM NO. 1 TO THE TENDER NO. KP1/6.E/OT/8/22/B01 FOR DESIGN, SUPPLY, INSTALLATION AND COMMISSIONING OF EXTENSIONS OF MV LINES, LV SINGLE PHASE LINES AND SERVICE CABLES FOR THE LAST MILE CONNECTIVITY PROJECT (AFD/EU).

The following amendments are made to the specified provisions of the Tender document for design, supply, installation and commissioning of extensions of mv lines, lv single-phase lines and service cables for the last mile connectivity project (AFD/EU).
